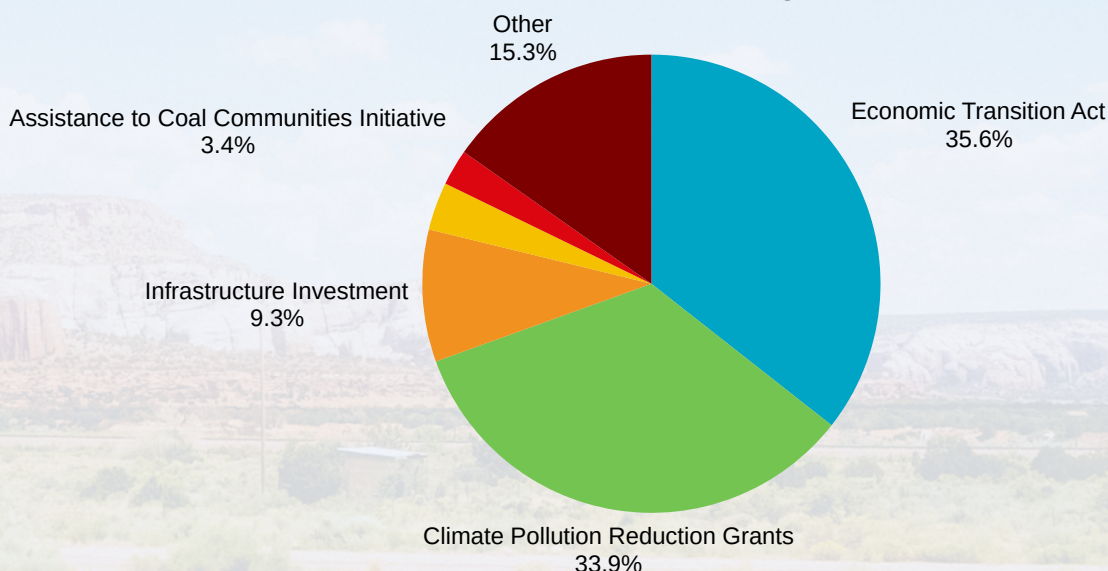

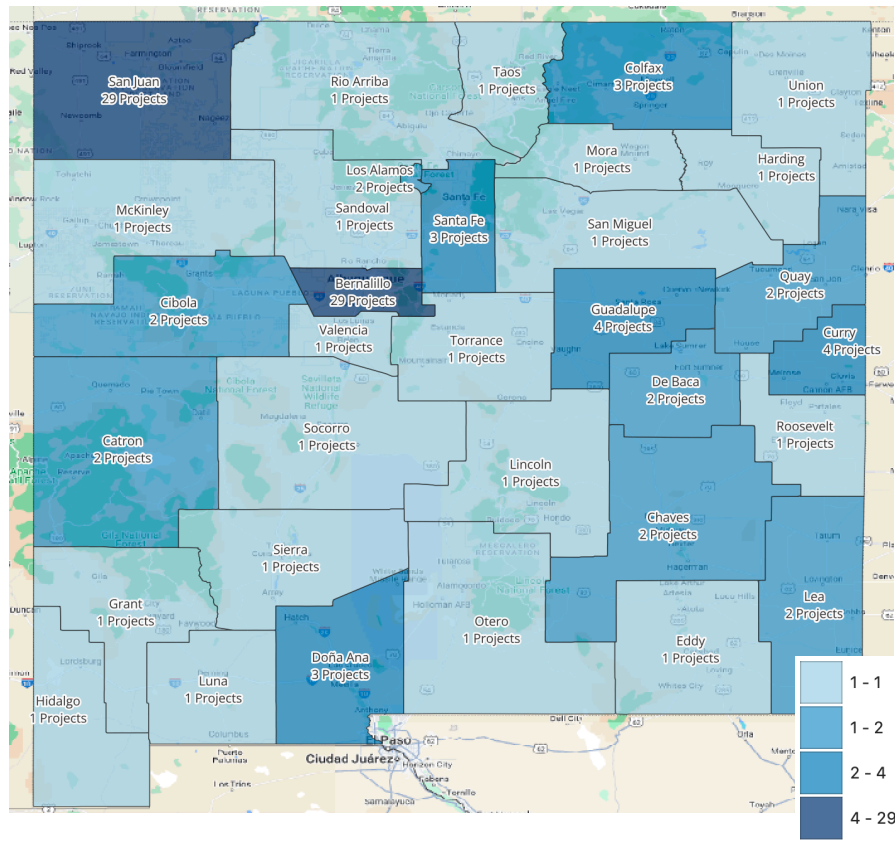

PROJECT EXAMPLES



Energy Efficiency

Pre-Weatherization for Low-Income New Mexicans - Conducting structural repairs and home health remediation to enable previously deferred or ineligible low income homes to access incentives for weatherization, energy efficiency, electrification, and renewables.



Transportation

\$1 million for repairing or reconstructing West Brasher Road in Chavez County



Clean Energy

Peregrine Energy proposes an \$230 million energy storage project that promises to transform approximately 30 acres of land into an energy storage powerhouse in Eddy County.



Grid Modernization

\$600k for grid modernization software for Central New Mexico Community College.



Workforce Development

\$7 million for a solar technician apprenticeship program for displaced workers in the San Juan County/Four Corners region
